#### PLEASE NOTE

**All dogs competing must be registered with AAC and have a valid registration number before entries will be accepted.** *If your dog does not have an AAC registration number, please complete the registration form provided on the AAC website at [www.aac.ca](http://www.aac.ca).*

**IMPORTANT.** Please check your dog's AAC registration number on your trial confirmation as soon as you receive it. Also, please check the copy of the results posted after the trial. You should report any errors to the Trial Secretary immediately.

When not competing, dogs must be penned, crated, or leashed. Dogs must be under control at all times when entering and exiting the trial ring and warm-up areas. Exhibitors are required to supply their own chairs, crates/pens for benching. Exhibitors must keep benching and exercise areas clean. Please clean up after yourselves and your dogs. Anyone who does not do this may be excused from the trial by the Trial Committee.

I (we) agree that the club holding this event (Newfoundland Athletic Dog Association, Inc.) has the right to refuse this entry for any reason which the organizing committee deems sufficient. In consideration of the acceptance of this entry, the holding of the event and of the opportunity to have this dog participate to be judged, I (we) agree as follows:
