# **NOTICE TO EXHIBITORS**

Exhibitors through the entry of this trial entry form, acknowledge that they are aware of the current AAC rules and regulations including, but not limited to the following:

This event will be held in accordance to the rules and regulations of the AAC (Agility Association of Canada). The obstacles shall be chosen from those that are described in the current version of AAC Official Rules and Regulations and shall conform the specification within.

All dogs regardless of breed are eligible to compete providing they are of 18 months of age (no exceptions), safe to be around other dogs and handlers, in good health both mentally and physically.

You must have an assigned AAC card and number (to accompany dog/handler team at trial check in) in order to compete – this also includes FEO runs. The application form for the card is available at <a href="https://www.aac.ca">www.aac.ca</a>.

All dogs are expected to be **under control** (penned, kennelled, leashed, etc.) when not in the ring. Please take responsibility for your dogs, children and family. Any exhibitor whose dog, child or family creates a disturbance, or engages in unsafe or disruptive behaviour may be asked by the Trial Committee to leave the event site. There will be no refunds offered for trial fees should a handler be dismissed from the site for any reason. Waivers must be completed on our online store prior to the event start.

# **EQUIPMENT INFORMATION**

- All contacts are rubberized (teeter: steel frame with wood board; dog walk: aluminum frame with wood board; A-Frame: aluminum frame with wood board and slats).
- All single jumps (winged and wingless) are DoggyJumps with single cups and 4' or 5' poles.
- Double bar jump is wingless with plastic permanent cups and no connecting bar (separate standards).
- Ascending is winged with plastic permanent cups and separate standards.

- The tire is breakaway and self-healing.
- Tunnels are standard or sure-grip.
- The event timing will be electronic unless there are weather or technical issues.

### **SITE INFORMATION**

There will be one outdoor fenced (snow-fencing) 100'x100' ring with a grass surface. Trial will proceed rain or shine.

Start Time: All hands-on deck for 8:00AM for setup. Height measurements at 9:00AM and first dog on the line at 9:15AM. Times may vary depending on efficiency.

#### **ENTRIES**

- The Newfoundland Athletic Dog Association (NADA) reserves the right to refuse entry. You must also be in good standing with the Agility Association of Canada (AAC).
- Entry opening date is **April 20, 2024** and will close on **June 20, 2024.** \*\*No entries will be accepted after the closing date\*\*
- Limited entries and parking availability. Please carpool if possible.
- Bitches in season (BIS) will be allowed to compete. Owners can request refunds for BIS if owner decides to withdraw(see back of premium for requirements for BIS at AAC Trials)\*. BIS will be required to wear panties at all times while on site including when they run.
- Please include all information requested on the registration/trial premium (print clearly) as the information is important for emailing confirmations of entry and result reports that are forwarded to the AAC for record and posting.

- Payment for runs can be made in one of two ways:

 Cash/Cheque - make cheques payable to Newfoundland Athletic Dog Association and include a signed copy of trial entry form. A NSF fee (\$25.00) will apply to declined cheques

\*\*The completed trial premium (entry form, signed waiver form and volunteer form) and accompanying fees must be received by the trial secretary before the entry closing date specified.\*\*

• Entry refunds will be provided for medical reasons for dog and handler, provided the trial secretary is informed prior to the trial date.

### PRIZES AND AWARDS

All dogs with a qualifying score will be awarded a qualifying ribbon. As well, in each of the Events first to fourth place ribbons will be awarded in each height division. In the Veterans and Specials rounds, first to fourth ribbons will be awarded in each height division combined. Title ribbons will also be awarded to those who complete an AAC designated title. Additional fun prizes may be presented at the trial.

# **AAC CLASS DECRIPTIONS**

Starters: Open to dogs that <u>have not</u> earned an ADC or SGDC title\*

**Advanced:** Open to dogs that <u>have not</u> earned an AADC or AGDC title\*

**Masters:** Open to dogs that <u>have</u> earned an AADC or AGDC title \*

**Regular:** Dogs run at standard jump heights as determined by their measurement. A-frame height

is set at 5' 6" and the ascending/double and spread jumps are used. The Standard Course Time (SCT) will apply according to the dog's Regular category division as defined by

AAC.

**Specials:** Open to all dogs and includes a drop in jump height (one height lower than the lowest of

the Regular jump height options), a lower A-frame height (5') and the absence of the ascending/double or spread jumps. Dogs running in the Specials division shall be given

the same SCT as dogs running in the corresponding Regular division.

**Veterans:** Open to any dogs aged 7 years and older who has been competing in the Regular division.

Also open to dogs 5 years of age or older who have been competing in the Specials division for a minimum of 12 consecutive months immediately preceding the move to Veterans division. Once a dog has competed formally in a trial within the Veterans division, they can no longer compete in the Regular or Specials division. For any given trial, the handler may opt for a "single drop" (one jump height lower than Regular height) or a "double drop" (two jump heights lower than Regular height), but they may not change heights within a single trial. A-frame height is set at 5' and ascending/double or spread

jumps are not used.

**FEO:** This option is available for competitors to enter classes "for exhibition only". FEO entries

are not formally judged, nor are they eligible to earn "Q's" or placements. You must have

an AAC card and number to enter a FEO run, and the jump height is your choice.

\* Competitors are responsible for keeping track of their dog's acquired legs and titles. Please refer to the AAC Official Rules and Regulations handbook at <a href="https://www.aac.ca">www.aac.ca</a> for more information.

<sup>\*</sup> Move-ups will be allowed on the second day of the trial.

### \*Requirements for BIS at AAC Trials:

At any AAC event where BIS are allowed to compete, the following conditions will apply and must be clearly stated in the club premium:

- 1. Handlers are requested to notify the trial secretary that they will be running a BIS at the event as soon as it is known.
- 2. It must be stated that handlers should minimize exposure of their BIS to other dogs and limit their movements about the grounds.
- 3. Competitors will be notified there is a BIS on site.
- 4. A protective mat shall be used at the start line. The club premium must state whether the mat will be provided by the host or the competitor.
- 5. The club premium must state whether BIS will be required to run in protective panties.
- 6. BIS will run as a group at the end of each class.
- 7. "BIS" will be noted next to the dog's name on the gate sheet so that other competitors, ring crew and the Judge(s) are aware.
- 8. BIS must use a designated relief area.
- 9. BIS must wear protective panties when not running or not within the designated relief area. Regardless of whether the BIS are allowed at a particular trial, or not, competitors with dogs that come into season will be allowed to withdraw and will be offered a refund or (optional) credit of they choose not to compete.

# For handlers with BIS the following requirements will apply:

- 1. Handlers are requested to notify the trial secretary that they will be running a BIS at the event as soon as it is known.
- 2. Handlers should minimize exposure of their BIS to other dogs and limit their movements about the grounds.
- 3. Competitors will be notified there is a BIS on site.
- 4. A protective mat shall be used at the start line. The club will provide the protective mat for BIS.
- 5. NADA will require BIS to run in protective panties, and protective panties **WILL** be required at all other times expect in the special designated relief area.
- 6. BIS must wear protective panties at all times except within the designated relief area.
- 7. Competitors with dogs that come into season will be allowed to withdraw and will be offered a refund or (optional) credit of they choose not to compete.
- 8. BIS will run as a group at the end of each class.
- 9. "BIS" will be noted next to the dog's name on the gate sheet so that other competitors, ring crew and the Judge(s) are aware.
